ACT Government Budget hot or not?

The Youth Coalition of the ACT 2005 / 06 Budget Submission listed 25 recommendations to address gaps in critical youth services and the sustainability and continuing viability of the youth sector. These recommendations were identified through a consultation process with members and other key stakeholders. We are very disappointed that none of our recommendations were adopted.

The Youth Coalition is pleased with many of the new initiatives in this year's budget and recognises that the Government has taken some positive steps forward, including the implementation of some of the recommendations from the reports on the child protection system known as the Vardon and Murray reports.

We particularly applaud the establishment of the Commissioner for Children and Young people whom we look forward to working closely with.

However, the Youth Coalition is disappointed that many aspirations of the Canberra Plan remain purely aspirational. The Government has missed a valuable opportunity to invest in prevention and early intervention services and continues to play catch up.

The ACT Government has repeatedly said that this is a tight budget and we are facing tight times – despite this more funding has been allocated to feasibility studies than to address drug related harm.

The true test of a community is how it supports its most vulnerable – and on this occasion the Budget has, fallen short of the mark.

New initiatives

The Youth Coalition welcomes the announcement of new initiatives for young people with disabilities, Aboriginal and Torres Strait Islander young people, children and young people in the care and protection system and the establishment of a Commissioner for Children and Young People.

The Youth Coalition put the need for a Commissioner for Children and Young People on the public agenda and is pleased that the ACT Government has established this important position.

The Youth Coalition is pleased to see the ACT Government has adopted a new community sector method of indexation, but is bitterly disappointed that this initiative will not begin until July 1st 2006.

Service gaps

The lack of indexation this financial year is a blow to youth services funded through the Youth Services Program. They missed out on indexation all together in the 2002 / 03 Budget. Youth services are already behind and the community sector again has not had major issues of viability addressed.

The ACT Government's Budget has also failed to address the needs of young people from culturally and linguistically diverse backgrounds, homeless young people, and young people with mental health and drug issues.

The ACT Government has neglected to provide support for young people with mental health issues. This is a major concern especially considering the growing numbers of young people contacting services such as Lifeline who have reported increased incidents of young people who self-harm. The Youth Coalition had called for a number of new measures to be funded addressing the mental health needs of young Canberrans including; increased emotional and social health services, accommodation, an adolescent in-patient unit and step-down residential facility, and training and program responses to self harm.

Homelessness and housing affordability remains a huge issue in the ACT and the Budget does not deliver any increases in capital funding to Housing ACT. It appears that Housing ACT stock numbers will in fact decrease during the 2005/06 financial year due to redevelopment and refurbishment. This will exacerbate the already dire circumstances that many young people experiencing homelessness and poverty face daily.

The Youth Coalition is disappointed that no new funding has been allocated to alcohol and other drug initiatives in this year's budget, despite plenty of research (including recent ACT specific research) linking substance misuse to homelessness, poor mental health outcomes and child abuse and neglect. The impact of intergenerational drug use is in desperate need of readdress, especially considering recent findings to demonstrate a link between parental drug use and homelessness in the ACT. Investment in prevention and early intervention is critical to reducing drug related harm and is consistent with the *Alcohol, Tobacco and Other Drug Strategy 2004 – 2008*. Indigenous young people and young people with alcohol and other drug issues incarceration rates continue to be unacceptably high and this year's budget has ignored them.

Although we support the new initiatives for young people with disabilities, many of the most at-risk young people with disabilities have missed out on greatly needed supports. We are concerned about the number of young people with disabilities and mental health issues who are involved in the juvenile justice system and who are homeless.

ACT Government put on notice: community sector wage issues aren't going away

The Youth Coalition is pleased to see the ACT Government has adopted a new community sector method of indexation, but is bitterly disappointed that this initiative will not begin until July 1st 2006.

“The increased costs and pressures on community organizations has been continuously raised by the Youth Coalition and other community peaks over several years,” said Meredith Hunter, Executive Officer, Youth Coalition of the ACT.

“Another 12 months will make a significant difference to the community sector being able to provide support to some of the most vulnerable members of our community,” continued Ms. Hunter.

“This is also a blow to youth services funded through the Youth Services Program. They missed out on indexation all together in the 2002 / 03 Budget - youth services are already behind.”

“The Youth Coalition will be lobbying strongly that the introduction of the new indexation measure be implemented along with an increase in community sector wages in 2006. Another major community sector viability issue.”

“As the Government has responded positively to the wage demands of the public sector, nurses and teachers it is only reasonable that the wage inequities of the community sector are addressed in the 2006 – 07 Budget,” stated Ms. Hunter.

MISSING IN ACTION

The ACT Government has failed to address the needs of young people from culturally and linguistically diverse backgrounds, homeless young people, and young people with mental health and drug issues in its 2005/06 Budget.

“The Youth Coalition is disappointed that the ACT Government has again overlooked and failed to fund services for young people from culturally and linguistically diverse backgrounds,” said Meredith Hunter, Executive Officer of the Youth Coalition of the ACT.

“The ACT Government has also neglected to provide support for young people with mental health issues. This is a major concern especially considering the growing numbers of young people contacting services such as Lifeline who have reported increased incidents of young people who self-harm. The Youth Coalition had called for a number new measures to be funded addressing the mental health needs of young Canberrans including; increased emotional and social health services, accommodation, an adolescent in-patient unit and step-down residential facility, ”

“Homelessness and housing affordability remains a huge issue in the ACT and the Budget does not deliver any increases in capital funding to Housing ACT. It appears that Housing ACT stock numbers will in fact decrease during the 2005/06 financial year due to redevelopment and refurbishment. This will exacerbate the already dire circumstances that many young people experiencing homelessness and poverty face daily,”

“No new money was allocated to drug and alcohol initiatives despite plenty of research linking substance misuse to homelessness, poor mental health outcomes and child abuse and neglect.” Ms Hunter said.

Young people with disabilities: finally some much needed support

The Youth Coalition of the ACT is pleased to see that children and young people with disabilities will be supported by a range of new initiatives announced in the 2005-6 Budget.

“Many children and young people with disabilities have struggled to receive appropriate levels of support in the past – having a significant impact on their lives and those of their families.” Ms Hunter, Executive Officer, Youth Coalition of the ACT, said. “We believe that these initiatives will go some way in addressing their needs.”

The new initiatives announced included an intensive support service and additional therapy support for adolescents with challenging behaviours, and a day program for young people with disabilities to develop life skills.

In addition, increased supports were announced to help young people with disabilities to achieve better outcomes in their education.

“We are pleased to see that the Stanhope government is supporting young people with disabilities within education. We are concerned, however, that anti-disability cultures in our schools keep many young people from achieving their potential – something needs to be done”.

Though supportive of the initiatives, the Youth Coalition argues that many of the most at-risk young people with disabilities have missed out on greatly needed supports:

“Though we applaud these initiatives, the Youth Coalition is concerned about the number of young people with disabilities and mental health issues who are involved in the juvenile justice system and who are homeless. We are disappointed to see that no additional supports are available for these vulnerable and poorly supported young people”.
