## Budget Analysis Overview

The Youth Coalition of the ACT, the peak body for youth affairs, acknowledges the challenges faced by the ACT Government in developing the ACT Budget 2010/11, and welcomes the announcement of funding for some key initiatives.

The ACT Budget 2010/11 contains a few gains for young people, with a particular focus on improving supports for young people with disabilities, young people in Out of Home Care, and young people in detention. The Budget also features funding for young people aimed at improving access to legal information, and early intervention for young people experiencing violence in their family relationships.

However, the Youth Coalition is concerned about the lack of an overarching vision for the budget. The Youth Coalition is disappointed that the implementation of the goals of the *ACT Young People's Plan 2009 – 2014*, launched in December 2009, has not been identified as a priority for the 2010/11 financial year.

The Youth Coalition calls on the ACT Government to address service delivery, planning and support for young people and their families in a systematic and sustainable way. In particular crisis support services need to be complemented with a suite of long term intervention and prevention programs.

While this year's promising new spending initiatives are welcomed, much of the detail is still to come. We implore the ACT Government to take the opportunity to conduct significant consultations with young people and community youth services to identify the best ways in which these resources can be utilised to benefit young people in the Canberra community.

Some key initiatives announced in the ACT Budget 2010/11 are outlined below.

### Young People with Disability

---

- Funding the Home and Community Care Program an additional \$2.2 million, which will include supports for young people with disabilities;
- Funding of \$1.6 million over four years to provide further supports to young people with disabilities in schools;
- Funding of \$2.4 million over two years into disability support services; and,
- Funding of \$425,000 over four years to employ a community-based family support worker to support families who have a child with autism.

## **Young People in Care**

---

- Funding of \$5.7 million over four years to support young Canberrans in out of home care.

## **Multicultural Young People**

---

- Funding of \$105,000 over four years to Multicultural Youth Services to provide support to multicultural, newly arrived and refugee young people.

## **Young People in Bimberi Youth Justice Centre**

---

- Funding of \$7.1 million over four years to Bimberi Youth Justice Centre, of which part will go towards ensuring human rights compliance.

## **Legal**

---

- Funding of \$785, 000 over four years to the Youth Law Centre to increase capacity; and,
- Funding of \$200,000 over four years for an Indigenous Liaison Officer in the Legal Aid Commission.

## **Domestic Violence**

---

- Funding of \$2 million over four years to provide further support to women and children experiencing violence, including early intervention for children and young people experiencing violence in their family relationships.

## **Young People and Education**

---

- Funding of \$1.1 million over four years to support the Youth Attainment and Transitions National Partnership by increasing the engagement of young people in education, training and employment.

## Infrastructure

---

- Funding for regional infrastructure, including CIT Vocational Education in Gungahlin, a new Gungahlin Library, and a Gungahlin Health Centre.

## Youth Services

---

- One-off funding of \$70,000 to Warehouse Circus Community Program.

## Youth Sector Viability

---

The ACT Budget 2010/11, under the 2010/11 priorities of the Department of Disability, Housing and Community Services clearly articulates its commitment to working with the community sector to build their sustainability and industrial relations capacity. However, no funding has been allocated towards resourcing this commitment.

Like many sections of the community sector, community based youth services continue to experience significant challenges with regard to workforce development, recruitment and retention of workers, while also facing increased demand for service provision. The increasingly complex nature of the issues youth services and workers are supporting young people with also highlights the challenge of skill development in a sector that must be both pre-emptive and responsive to the changing needs of young people, and have such a broad range of response knowledge.

The viability of the ACT youth and community sectors is important, to ensure that the service system is set up to support young people, able to further develop to address emerging issues and provide targeted support to young people..

The Youth Coalition, in our submission to the 2010 / 11 Budget called for the following key actions in relation to the youth and community sectors:

- Implementation of the 30 recommendations outlined in the ACT Council of Social Service (ACTCOSS) report, *Finding Solutions: Towards the long term viability of the ACT Community Sector*,

- Investment in workforce development strategies for the youth and community sectors;
- A commitment to no reduction in the funding level supporting young people aged 12 – 25 years within the new service framework that will come into effect during the 2010/11 Budget;
- Development of an updated social and demographic profile of young people in the ACT;
- Contribution of funds to enable the Youth Centre’s Network to progress modelling to:
  - Further develop Youth Centre practice;
  - Contribute to the evidence base informing Youth Centre practice; and,
  - Inform future funding of youth services.
- Provision of funding to further develop a Code of Ethics for Youth Work in the ACT;
- Ensuring that the Youth Coalition is able to continue to support specific networks within the youth and community sector which aim to strengthen supports and services for young people aged 12 – 25 years; and,
- Ensure that funding is available to support the continued production of the Big Red Book.

Youth and community sector organisations cannot continue to deliver high quality programs and services with staff shortages, high turnovers and an inability to attract suitably qualified or experienced workers.

The Youth Coalition is pleased that the ACT Budget 2010/11 addresses some gaps in services, with significant spending commitments, and we look forward to working with the ACT Government and other community stakeholders in implementing the initiatives from this budget that relate to young people and youth services.

## ACT Health

The Youth Coalition identified the following areas relating to Budget initiatives raised in the 2009/10 ACT Budget, that we seek clarification on in the 2010/11 financial year:

- *Rollover of \$1.3 million for the Healthy Future – Preventative Health Program to 2010/11:* The Youth Coalition strongly supports the initiatives included in the Healthy Future Program, and seeks clarification on what specific activities have been rolled over and will be implemented in the 2010/11 financial year, including an update on the feasibility study for a Centre of Adolescent Health.
- *Rollover of \$447,000 for the GP Workforce Initiatives to 2010/11:* The Youth Coalition strongly supports the initiatives included in the GP Workforce Initiatives, and seeks clarification on what specific activities have been rolled over and will be implemented in the 2010/11 financial year.

The Youth Coalition identified a number of areas in the Strategic Indicators and Accountability Indicators, for further consideration by the ACT Government:

- *Strategic Indicator 5 - Maintaining Consumer and Carer Participation:* The Youth Coalition strongly supports the commitment by ACT Health to ensure that 100% of Mental Health ACT committees have representation by consumers and carers. However, we would like to highlight the importance of ensuring that consumer and carer participation is well-planned, adequately resourced, and meaningful, and recommend that evaluative mechanisms be implemented to ensure this is measured.
- *Strategic Indicator 22 – Reduction in the Youth Smoking Rate:* The Youth Coalition strongly supports the ACT Health priority to reduce the percentage of young people aged 12 – 17 years who smoke regularly. However, we call for clarification on the goal to reduce the rate to 5% in the 'long-term', and recommend the identification of a concrete timeframe.
- *Output 1.3e – Proportion of Offenders and Detainees in Bimberi Youth Detention Centre with a Completed Health Assessment within 24 Hours of Detention:* The Youth Coalition supports the inclusion of a 100% completion rate of young people in Bimberi Youth Justice Centre receiving a completed health assessment. In addition to these accountability indicator, we recommend that an additional indicator be included measuring the implementation rate of health care plans.

## Department of Disability, Housing and Community Services

The Youth Coalition is concerned that the *ACT Young People's Plan 2009 – 2014* (the ACT Young People's Plan) has not been specified in the 2010-11 priorities for DHCS, where other ACT Government strategies have been identified. The ACT Young People's Plan included a commitment to implementing the *Child Friendly Cities Initiative*, in which child and youth participation is a key component in the planning and delivery of ACT Government activities. No specific funding has been allocated to the implementation of this important initiative.

The Youth Coalition identified a number of areas in the Strategic Indicators and Accountability Indicators, for further consideration by the ACT Government:

- *Strategic Indicator 6 – Promote Participation in Community Life by Canberrans including those from Culturally and Linguistically Diverse Backgrounds:* While the Youth Coalition supports the commitment by the ACT Government to promote participation by people from culturally and linguistically diverse backgrounds, we are concerned that the measure (the number of groups participating in the Annual National Multicultural Festival) is inadequate. This Strategic Indicator should also consider broader participation in the community, including participation in employment and education opportunities, and access to services and community activities.
- *Strategic Indicator 8 – Meeting Individuals' needs through Case Management and Appropriate Services and Programs:* The Youth Coalition is pleased that the ACT Government is working towards a greater proportion of children and young people experiencing no more than 2 placements in care. However, we believe that the ACT Government should be progressing towards a higher proportion of children and young people (than 60 – 70%) experiencing no more than 2 placements. Additionally, we are concerned that the measure is inadequate and should also consider children and young people's experiences and outcomes of care.
- *Output 3.1a – Number of Training Sessions provided for Community Sector Organisations:* While the Youth Coalition supports the provision of ACT Government funded training for community sector organisations, we seek further clarification on what type of training will be provided, and highlight the importance of ensuring that the ACT Government works with the community sector to identify training needs.
- *Output 3.1c – Number of Community Capacity Building Projects Supported:* While the Youth Coalition supports the provision of ACT Government grants to build the capacity and sustainability of community organisations, and to address disadvantage in the community,

we are concerned that these grants are piece-meal, and call for the ACT Government to address these issues in a systematic and sustainable way.

The Youth Coalition is also concerned that while DHCS and OCYFS are looking to make significant change in the framework for Youth Support Program and Family Support Program service purchasing there has been no change in the strategic indicators and accountability indicators for children and young people and families in this area.
